Notes to Compiled Financial Information

Year Ended December 31, 2024

1. BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of Association of Community Organizations for Reform Now, Canada as at December 31, 2024, and the statements of changes in net assets and operations for the year then ended is the historical cost basis, reflecting cash transactions with selected accruals and accounting estimates:

- Accounts and grant receivable less an allowance for doubtful accounts
- · Prepaid expenses for the portion of expenditures applicable to next year
- Capital assets (property, plant and equipment) and website amortized over their useful lives
- · Accounts payable and accrued liabilities
- · Wages and salaries payable
- Deferral of grant revenue until terms of use are satisfied

2. REMUNERATION DISCLOSURE

In accordance with the Societies Act of British Columbia, Association of Community Organizations for Reform Now, Canada is required to disclose that there was one individual that exceeded \$75,000 of annual remuneration that was paid a total sum of \$75,537.
